3. Privacy policy

How personal data submitted through this website is handled.

3.1 Who is responsible

FIDEVO FINANCE S.R.L. (CUI 54682381), with registered office in Intrarea Vladimiri, Nr. 11-17, Camera 1, Ap. 2, Sector 5, București, Romania, is the controller for personal data collected through this website.

3.2 What we collect

Data you submit yourself through contact or enquiry forms and the site assistant - typically your name, email address, company, and the content of your message. We also process basic technical data such as IP address and browser information needed to serve and secure the site.

3.3 Why we use it

To reply to your enquiry, to provide and secure the website, and to keep records of business correspondence. We do not sell personal data.

3.4 Legal bases

Depending on the case, we rely on your consent, on steps taken at your request before entering a contract, on the performance of a contract, or on our legitimate interest in operating and securing the site and responding to business enquiries.

3.5 Processors and transfers
